Steve Testa of Romano, Hearing, Testa & Knorr thanked the board for the reappointment as the BBMUA's Auditor for the incoming year. He informed the board that his contract was provided for execution in accordance with the response to the Request for Qualifications. The contract is for the period February 1, 2022 through January 31, 2023.

Mr. Testa informed the board that the GASB 75 was distributed by the State of New Jersey today. This report is required to complete the BBMUA's 2020 Audit. Mr. Testa will keep the board informed of the progress with the annual audit.

Jason Capizzi of JP Capizzi Law Office forwarded the proposed contract for execution in accordance with the response to the Request for Qualifications and needs to be executed. The contract is for the period February 1, 2022 through January 31, 2023.

A copy of the letter received from the State of New Jersey Department of the Treasury Division of Pensions and Benefits providing the 2022 Employer Liability for the Annual Pension Contribution to PERS was given to the board. This invoice must be paid by April 1, 2022.

Cheryl Santore informed the board that Mary Pearsall of the New Jersey I Bank submitted the accrued interest statement for the month ending January 31, 2022. This interest is being accrued and will be rolled into the permanent financing for the Pump Station Rehabilitation Project.

Cheryl Santore obtained a quote from Dell for two new computers for the office. The total quote obtained is \$2,874.04. Our computers have been freezing up while we are working and we have to keep rebooting them. The computers we have now are over 8 years old. We budgeted the money to replace them in 2021 but did not do so. Ms. Santore stated if the board is in agreement a motion is needed to approve the purchase of two new computers from Dell per quote no. 3000110922024.1 in the amount of \$2,874.04 for the BBMUA office.

Plant Superintendent Alan Zorzi obtained a quote from Falasca Mechanical who we are under contract with to demo an existing fan coil. In the plant there is a boiler system that has been in existence since 1969 when they originally built it. This coil is currently leaking over the new control panel for the plant that we just upgraded. The quote received was for a cost not to exceed \$6,276.00. Falasca will demo the existing fan coil, extend the piping to move it away from the new control panel, install the new fan coil unit, thermostat and all of the hangings.

m/Delano s/Johnston to approve the demolition and purchase and installation of a new fan coil to the boiler system in the plant by Falasca Mechanical for a cost not to exceed \$6,276.00. m/passed
