The meeting took place via freeconferencecall.com phone in meeting software due to the COVID-19 pandemic and no one being allowed to gather in large groups in person per order of the Governor of the State of New Jersey and the President of the United States of America.

The meeting was called to order by Chairman Joseph Santagata.

Robert Smith of Remington & Vernick provided a copy of payment certificate #5 to Michael Itri of MBE Mark III, Inc. for signature for the rehabilitation of the pump stations and grit system project. That payment certificate has been signed and is on the bill list for approval at tonight's meeting.

Robert Casella of Testa, Heck, Testa & White informed the board the finalized AT&T cell tower lease agreement was received. The amendment has been verified with the changes that were agreed upon in the discussions at the regular May 26, 2021 meeting of the BBMUA board. The agreement will need to be signed via DocuSign which will electronically submit the contract to AT&T. The BBMUA Board will need to adopt the resolution verifying and accepting the lease agreement.

m/Baker s/Delano to adopt resolution R-21-2021 amending an emergency purchase contract for an emergency repair on the sludge mixing truck from Bayview Bearing & Supply, LLC. For an additional cost of \$5,281.65 bringing the total emergency repair cost to \$57,281.65 from the previously approved \$52,000.00. m/passed

Secretary Cheryl Santore informed the board that the USDA compliance review was completed and all went well. Ms. Tort asked us to keep the USDA in mind for funding for future projects and provided a brochure on the water and wastewater disposal loan & grant program.

Mr. Jay Black, Vice President of Development for Diamond Properties who is the new owner of the Buena Vista Campground was present at tonight's meeting. They are in the process of starting the preliminary phases of engineering to convert the property over from onsite septic systems to ultimately applying to put all waste into the BBMUA's system to comply with the Pinelands Commission Memorandum of Agreement that was enacted in 2011. The Pinelands Commission had originally stipulated that the flows would be 65,000 gallons per day based on NJDEP calculations but after working with the engineering team and also leveraging information from their 5 other campgrounds located in surrounding states it appears that the estimated calculation at peak will be 18,000 gallons per day. They are a seasonal campground and peak means a very finite period of time during weekends and holidays throughout the seasonal months. Most of the time during off peak season they will hit a low of about 3,000 gallons per day based on the limited number of annual sites they have within the park. Chairman Santagata asked those in attendance if they had any questions and thanked Mr. Black for providing the update to the board.

Plant Superintendent Alan Zorzi informed the board that the Insight Pro support 2 year contract for the GE MBR membrane system is set to expire on August 16, 2021 and needs to be renewed. The cost of the 2 year contract is \$15,120.00 or \$7,560.00 per year.

m/Baker s/Delano to purchase a 2 year service agreement for Insight Pro support for the GE MBR membrane system in the amount of \$15,120.00. m/passed

Pricing was obtained for asphalt restoration for 145 Route 54, 108 Arbor Avenue, and the corner of Irene Avenue and Route 40. These are all locations where we have had to do repairs on our water lines during the year. Three quotes were attempted and Frank Wells Paving came back with a quote of \$5,000.00 total for all three restorations.
