Chairman Brunini explained the quotation from Falasca Mechanical to replace the existing heating/cooling equipment at the plant. This correspondence is not a quotation but a proposal with an amount not to exceed. Falasca Mechanical has our maintenance contract so this should have been broken down by labor, equipment, etc. The heating and cooling in the office area at the plant is an old existing unit which uses a lot of energy and is completely shot. They can not get parts for it any longer. We have to call Falasca out approximately 4 times per year. The duct work is rusting out and water is coming down through the walls. Falasca was asked to replace this unit with two units that go through the wall. If one of the units goes bad you just replace the unit.

m/Soto s/Bertonazzi to replace the existing heating and cooling unit at the plant in the office area by Falasca Mechanical for a cost not to exceed \$17,160.00 as stated in proposal.

Mr. John Peterson the Deputy Director of the Atlantic County Department of Regional Planning and Development sent a letter to Mayor Joseph Baruffi with their final proposed future wastewater service area map. The board wants Council to understand that just because sewer is allowed on this map it does not mean that we will run sewer service to the north side of Harding Highway. It is not worthwhile or cost effective to do so.
