#2 Letter to the NJDEP, the NJ Department of Community Affairs, and the Board of Public Utilities notifying them that the BBMUA is committed to cooperate with all agencies in keeping the water on for our customers during the public health emergency created by the spread of COVID-19. Therefore, the BBMUA will suspend shut offs for reason on non-payment of services until the outbreak has subsided.

Results of the online auction that was held today by EMEX on behalf of the BBMUA. It appears that will provide us with a rate of \$ per kWh for a term of months. This rate is \$ higher/lower than our current rate with Constellation (\$0.09186/kWh) due to the plant utilizing green solar energy. EMEX estimates this will result in a savings of approximately \$ per year than if we were turned back over to Atlantic City Electric. However, the savings can be greater depending on Atlantic City Electrics fluctuating rate. The rate of \$ will be a fixed rate. If the board approves this the contract will need to be signed tonight and returned to EMEX in the morning.
I need a motion to approve the signature of the contract for electricity for a period of months with at a fixed rate of \$ per kWh for all meters which includes any power used by the plant that is not serviced by the Solar contract at the BBMUA sewer plant.
