WHEREAS, the Authority's Engineer, Remington & Vernick Engineers has recommended that the Authority accept the lowest responsible bid as submitted by Warriner's Construction, Inc.; and

WHEREAS, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that all action taken by the Authority's Engineer, Remington & Vernick Engineers, in publishing specifications for bids and the

subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible bid for the published services, be and these actions are hereby confirmed and approved.

BE IT FURTHER RESOLVED that the Secretary of the Authority is hereby authorized to return all bids, certified checks and/or bid bonds to any and all rejected bidders.

BE IT FURTHER RESOLVED that the proper officers of the Authority be and they are hereby authorized to execute any and all documents required with respect to the awarding of a one-time contract fee in the amount of \$30,240.00 for the furnishing and delivery of wood chips.

Dear Chairman Santagata:

We have reviewed the bids received on December 3, 2020 with reference to the above captioned project. Two (2) bids were received.

The apparent low bidder was Warriner's Construction, Inc, 127 Summit Avenue, Egg Harbor Township, New Jersey 08234 with a bid in the amount of \$30,240.00. This equates to furnishing and delivery of 2,400 cubic yards of wood chips at a unit price of \$12.60 over a two year contract term. A second bid was received from Yannuzzi Group, Inc., 135 Kinnelon Road, Suite 102, Kinnelon, New Jersey 07405 with a bid in the amount of \$40,800.00. This equates to furnishing and delivery of 2,400 cubic yards of wood chips at a unit price of \$17.00 over a two year contract term.

Therefore, in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq., the contract should be awarded to the lowest responsible bidder, which appears to be Warriner's Construction, Inc. with a bid in the amount of \$30,240.00. The award should be contingent upon approval of the MUA Solicitor and funds being available.

Based upon our review of the bid, we noted the following:

 Warriner's did not provide their DUNS Code or CAGE Code on the Certification of Non-Debarment for Federal Government Contracts. However, we obtained the DUNS Code from Warriner's and verified that they have no active exclusions.

By copy of this letter, we have provided Mr. Testa and Mr. Casella with a copy of the bid via e-mail. If Mr. Testa or Mr. Casella need to see originals of any documents, I would request that they contact my office.
