- 3. Pursuant to the terms of N.J.S.A. 40A:11-12 and N.J.A.C. 5:13-17.7, this Contract is awarded under the State Cooperative Procurement Program and without advertising for bids.
- 4. The sum of not to exceed \$88,912.00 is hereby authorized to be appropriated out of the Operations Fund for purposes of paying the purchase price due.
