WHEREAS, Warriner's Construction, Inc., having its principal place of business at 127 Summit Avenue, Egg Harbor Township, New Jersey 08234, submitted the lowest responsible bid in the amount of \$40,800.00 for the furnishing and delivery of wood chips; and

WHEREAS, the Authority's Engineer, Remington & Vernick Engineers has recommended that the Authority accept the lowest responsible bid as submitted by Warriner's Construction, Inc.; and

**WHEREAS,** the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that all action taken by the Authority's Engineer, Remington & Vernick Engineers, in publishing specifications for bids and the

subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible bid for the published services, be and these actions are hereby confirmed and approved.

**BE IT FURTHER RESOLVED** that the Secretary of the Authority is hereby authorized to return all bids, certified checks and/or bid bonds to any and all rejected bidders.

**BE IT FURTHER RESOLVED** that the proper officers of the Authority be and they are hereby authorized to execute any and all documents required with respect to the awarding of a one-time contract fee in the amount of \$40,800.00 for the furnishing and delivery of wood chips.
