**BE IT FURTHER RESOLVED** that the proper officers of the Authority be and they are hereby authorized to execute any and all documents required with respect to the awarding of a two-year contract covering the period from February 11, 2019 to February 10, 2021, inclusive of both dates, for mechanical and plumbing repair and maintenance services to Falasca Mechanical, Inc.
