WHEREAS, the Authority's Engineer, Remington, Vernick & Walberg has recommended that the Authority accept the lowest responsible bid submitted by Electron Services; and

WHEREAS, the Treasurer of the Authority has certified the availability of funds for a contract to be awarded to the lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED that the action taken by the Authority's Engineer, Remington, Vernick & Walberg, in publishing specifications for bids and the subsequent action taken by the Authority, in respect to its acceptance of the lowest responsible bid for the published services, be and these actions are hereby confirmed and approved.

BE IT FURTHER RESOLVED that the Secretary of the Authority is hereby authorized to return all bids, certified checks and/or bid bonds to any and all rejected bidders.

BE IT FURTHER RESOLVED that the proper officers of the Authority be and they are hereby authorized to execute any and all documents required with respect to the awarding of a two-year contract covering the period from February 11, 2019 to February 10, 2021, inclusive of both dates, for electrical repair and maintenance services to Electron Services.
