RESOLUTION AUTHORIZING THE CREATION OF TWO NEW CLASSIFICATIONS OF WATER RATES FOR SMALL COMMERCIAL AND INDUSTRIAL AND LARGE COMMERCIAL AND INDUSTRIAL UNITS

R-22-2002

WHEREAS, the Borough of Buena Municipal Utilities Authority (hereinafter the "Authority") has determined that it is necessary to create two new classifications of water rates pursuant to N.J.S.A. 40:14B-23; and

WHEREAS, the two new classifications will be that of Small Commercial and Industrial units, and Large Commercial and Industrial units; and

NOW, THEREFORE, BE IT RESOLVED by the Borough of Buena Municipal Utilities Authority that the two new classifications of Small Commercial and Industrial units, and Large Commercial and Industrial units will have rates as follows:

SMALL COMMERCIAL AND INDUSTRIAL UNITS (1" and 2" connections)

1" and 2" connections shall be charged a minimum quarterly rate of \$63.50 for 15,000 gallons per quarter. This rate reflects the same rate as residential 1" and 2" connections for 15,000 gallons per quarter. The overage shall be charged at a rate of \$1.50 per 1,000 gallons, up to the amount of 240,000 gallons per quarter. Any usage amount over 240,000 gallons per quarter shall be charged the rate of \$2.00 per 1,000 gallons.

LARGE COMMERCIAL AND INDUSTRIAL UNITS (4" connections and larger)

4" connections shall be charged a minimum quarterly rate of \$1,016.00 for usage up to 240,000 gallons per quarter. The overage shall be charged a rate of \$1.50 per 1,000 gallons on the next 240,000 gallons. Any usage amount over 480,000 gallons per quarter shall be charged the rate of \$2.00 per 1,000 gallons.

6" connections shall be charged a minimum quarterly rate of \$2,286.00 for usage up to 540,000 gallons per quarter. The overage shall be charged a rate of \$1.50 per 1,000 gallons on the next 540,000 gallons. Any usage amount over 1,080,000 gallons per quarter shall be charged the rate of \$2.00 per 1,000 gallons.

These rates shall become effective December 1, 2002.
