## Administrative Order No. 2012-12

I, Bob Martin, Commissioner of the New Jersey Department of Environmental Protection (Department), pursuant to the authority vested in me by the Water Supply Management Act, N.J.S.A. 58:1A-1 et seq., and its implementing rules, N.J.A.C. 7:19, as well as by Executive Order No. 103, issued by Governor Chris Christie on October 31, 2012, hereby order mandatory statewide water use restrictions, as set forth below.

Based upon the current's ate of emergency associated with Hurricane Sandy and the water supply conditions described below, I find that there is an impending water supply shortage of a dimension which endangers the public health, safety and welfare in the State of New Jersey. Therefore, I have determined this to be necessary to alleviate the water emergency and to be in the general public interest.

Although the State's wat a supplies are not directly threatened at this time, significant compromises to the ener y supply in the wake of Hurricane Sandy may negatively affect the ability to maintain the water supply system and dictate the need for all New Jerseyans to conserve water to the maximum extent practicable. While this Order outlines specific water use prohibitions and exemptions, every resident, business and visitor is urged to use water wisely and to minimize water use be th in-and outdoors as much as possible.

## SECTION I. Statewide Water Use Restrictions

- 1. All indoor water use (including for showers, baths, and domestic cleaning) shall be conducted such that the minimum amount is used to accomplish the given task.
- 2. The serving of water in restaurants, clubs or eating places is prohibited, unless specifically requested by the patron.

- 3. The washing of a 1y vehicles other than fire, police, and other related emergency vehicles (including HAZNIAT vehicles) is prohibited, except in the following cases:
  - A. Washing if vehicles performed by a commercial enterprise engaged in car washing is permitted, provided the following requirements are met:
  - i. Vehicles: hall not be pre-rinsed except with recycled water;
  - ii. Rinse cyc es shall be forty (40) seconds or less per vehicle, which may be accomplished by increasing conveyor speeds;
  - iii. Additions | measures shall be implemented to minimize water use, such as reducing the : ize of water nozzles where possible and plugging all unnecessary outflows; and
  - iv. All fixtures and equipment shall be inspected for leaks on a daily basis. Necessary repairs shall the made immediately.
- B. Cars and trucks a dealerships may only be washed just prior to delivery to customers or placement in display sho vrooms;
  - i. The amount of water used shall be the minimum necessary, and rinse time shall be no longer ( an 2 to 3 minutes;
  - ii. All hoses must not leak and shall be equipped with a hand-held nozzle that automatically shuts off when released; and
  - iii. Wash and or rinse water shall be recycled to the extent practicable.
- C. Boats and other n arine vessels at dealerships and marinas may be washed for sanitary reasons as determined to be necessary in the interest of public health and safety.
- 4. The use of water for vashing impervious surfaces, including but not limited to, streets, roads, sidewalks, driveways garages, parking areas and patios is prohibited, except in the following cases:
  - A. Roadway nilling, and for the preparation of asphalt street or driveway re-coating and sealing, provi led the amount of water used is the minimum necessary;
  - B. For paved surfaces at eating and drinking establishments is permitted for sanitation purposes, provided the amount of water used is the minimum necessary;
  - C. For munic pal street sweeping, provided that:
    - i. Only r on-potable water is used;
    - ii. The ar tount of water used is the minimum necessary; and

- iii. An ar propriate sign is prominently displayed on the street sweeping vehicle, clearl, indicating that the water used is non-potable water; and
- D. Where the municipal or county health department deems that such washing is necessary to avert a threat to public health or safety, and provided that the amount of water t sed is the minimum necessary.
- 5. The use of water for power washing of buildings, vehicles, pavement, or other surfaces is prohibited, except if the power washing is performed by a commercial enterprise primarily engaged in power washing. A commercial power washing enterprise engaged in washing vehicles at a dealership shall comply with the limits for car washing at dealerships set forth at 3. above.
- 6. The outdoor use of any water for ornamental or aesthetic purposes, including fountains, artificial waterfalls and reflecting pools, is prohibited, except if necessary to preserve or support wildlife, or for sanitary constructural purposes where draining is impractical.
- 7. The watering of ¿ rass, lawns, and landscapes is prohibited, except in the following cases:
  - A. Lawn wat ring is permitted immediately following application by a commercial applicator of ferti izer, pesticide or herbicide, within the following limits:
    - The watering is permitted on the date that the chemical is applied.
       Docur tentation of the date of application shall be produced upon the request of the appropriate authorities;
    - ii. The watering may occur only during daylight hours; and
    - iii. The arrount of water used shall be the minimum necessary to ensure the appropriate absorption of the fertilizer, pesticide or herbicide, but in no case shall c reced 20 minutes per area watered.
  - B. Watering of newly (planted within 30 days of the effective date of this Order) seeded or sodded grassed areas by a professional landscaper during daylight hours, by a means designed and operated to assure effective conservation, provided that:
    - i. Watering of any single area is limited to 30 minutes.
    - ii. Watering is performed in accordance with 'The Rutgers Cooperative Extension Best Management Practices for Watering Lawns.'
    - iii. A sign shall be displayed on the front lawn of the property. The sign shall be at least for r feet wide by four feet high, with lettering large enough to be clearly visible fron the nearest road. The sign shall read:

- iv. Docume tation of the planting date shall be produced upon the request of the appropriate authorities.
- C. Lawn we tering is permitted if it is necessary for the re-vegetation of land in order to prevent soil er osion following earth-moving activities, provided that:
  - i. The amount of water used shall be the minimum necessary to accomplish the revegetation;
  - ii. The activity is a construction-related project that complies with the "Soil Erosion and Sediment Control Act" (SESCA), N.J.S.A. 4:24-39 et seq., or meets iii below;
  - iii. If the project is not subject to SESCA (i.e., a single family home or a project of less than 5,000 square feet), the project must be covered by a construction permit issued by the local municipal authority;
  - iv. The watering is limited to the disturbed area; and
  - v. Documen lation of the planting date shall be produced upon the request of the appropriate authorities.
- D. Testing o 'a newly installed or newly repaired sprinkler system by a commercial enterprise engaged in the installation or repair of lawn irrigation systems is permitted, within the following limits:
  - i. The amount of water used shall be the minimum necessary to test the sprinkler system;
  - ii. The test's rall be limited to a maximum of five (5) minutes per sprinkler zone; and
  - tii. During the period of the test a sign shall be displayed on the front lawn of the property. The sign shall be at least four feet wide by four feet high, with lettering large enough to be clearly visible from the nearest road. The sign shall read:

- E. All lawn vatering authorized herein shall use the minimum amount of water necessary.
- F. All lawn vatering authorized herein shall be performed in such a way that no puddling or runof of water occurs; and
- G. All lawn vatering authorized herein shall be performed in such a way that no paved surfaces are included in the area watered.

- 9 Watering of athlatic playing fields, including those owned, operated, and/or used by professional, college/un versity and youth league sports teams, as well as those owned or operated by public and private schools and parks, is permitted within the following limits:
  - A. Watering may not exceed 30 minutes per area watered on any one day;
  - B. No grass or dirt areas outside of the essential playing area may be watered;
  - . C. Under no circumstances shall a water cannon be used; and
  - D. Water conservation measures shall be instituted to the maximum extent practicable.
- The watering of a gricultural food crops, sod at commercial sod farms, and the watering of nursery stock at nurseries or retail outlets is permitted and is exempt from restrictions at this time, provided that all watering is done in accordance with best management practices, and:
  - A. The use and diversion from all sources is less than 70 gallons per minute; or
  - B. Any use and diversion of 70 gallons per minute or more is authorized by an approved, valid & gricultural Certification or Agricultural Water Use Registration.
- 11 The use of water 'or outdoor recreational purposes, not covered by paragraph 9 above, is prohibited, except that:
  - A. Golf cour es who possess a Water Allocation Permit or Water Use Registration issued by the Der artment may use water within the limits authorized in a valid permit or authorization, pre vided that:
    - i. Watering hall be conducted in accordance with The Rutgers Cooperative Extension E est Management Practices for Irrigating Golf Course Turf (in Adobe Acrobat PD ? format).

These restrictions and authorizations shall apply equally to all water users in the affected regions, regardless of whether the water used is drawn from ground or surface water (such as a pond, lake, river or stream), a public water supplier, or a private well.

Nothing in this Order shall be construed to prevent any local or county government from instituting water use restrictions that are more stringent, provided the local restrictions do not conflict with State or Fed ral law. These restrictions and authorizations may be modified and/or supplemented through ad litional Administrative Orders.

Any person who violates any provision of this Order or who impedes or interferes with

any action ordered or tak on pursuant to this Order shall be subject to penaltics under N.J.S.A. 58:1A-1 et seq., N.J.S.A. App. A:9-49 et seq., N.J.A.C. 7:19, or under N.J.S.A. 58:10A-1 et seq., N.J.S.A. App. A:9-49 et seq., and N.J.A.C. 7:14A. These enforcement sanctions range from a warning to a fine and/or imprisonment.

Municipal and county law enforcement agencies, as well as State law enforcement agencies, shall be responsible for enforcement of this Administrative Order and any subsequent Orders issued by the Corumissioner of Environmental Protection. Exemptions from the restrictions may be available from in limited cases. Any person wishing to be exempt wholly or partially from the restrict ons on water use outlined in this Order may apply for a hardship exemption according to the procedure outlined at N.J.A.C. 7:19-16.

This Order shall take effect immediately and shall remain in effect until superseded or terminated by my action or by action of the Governor of the State of New Jersey. All previous Orders issued by me shall remain in effect, except to the extent that they conflict with this Order.
