The Atlantic County Wastewater Quality Management Plan Update for the Final Proposed Sewer Service Area Maps were submitted to the NJDEP by the Atlantic County Department of Regional Planning and Development and it will be reviewed by the BBMUA's alternate member James DuBois. Once approved, these maps will be included in the new Atlantic County Wastewater Management Plan (WMP) in accordance with NJDEP Administrative rules N.J.A.C. 7:15.

m/Baker s/Mielke authorize the BBMUA's engineer Remington, Vernick and Walberg to prepare the new (2011 Project) bio plant design for the MUA not to exceed \$20,000.00 which will replace the previous effluent discharge project. m/passed

Chairman Brunini discussed the revised MOA with the board members and informed them that since the original discharge of the effluent to the Donato property has been changed to discharging the effluent into the Deep Run Stream. Chairman Brunini would like to use the MBR Membran Bioreactor system and be able to discharge 400 to 600 thousand gpd. The Pinelands wants the MUA to continue to discharge only 400 thousand gpd for a (2) year period and then allow the MUA to a 450 thousand gpd discharge. Chairman Brunini also informed the board members that the MUA should be allowed the 450 thousand gpd when signing the revised MOA.
